

## **Qatar Airways net profit** hits record QR6.1bn

atar Airways Group has reported the strongest financial performance in its 27-year history, announcing record profits of QR6.1bn for the 2023/24 financial year.

The national airline group earned a total revenue of QR81bn, representing an increase of QR4.7bn, up 6% compared to last year.

Qatar Airways Group generated a strong EBITDA margin of 24% at QR19.1bn, nearly QR1.2bn higher than the previous year, reflecting the business's continued focus on customer experience, innovation, digitalisation and sustainability, resulting in streamlined, agile and fit-for-



purpose operations across all

This has created a strong platform for the future of the group's airline business, which carried more than 40mn passengers during the 2023/24 fiscal, an increase of 26% over the previous

As a result, passenger revenue increased by 19%, with a capacity increase of 21% driven by the airline's highest-ever load factor

of 83%, offering a sustainable upsurge in market share.

Qatar Airways Group Chairman and HE the Minister of State for Energy Affairs, Saad bin Sherida al-Kaabi said: "This latest remarkable annual performance demonstrates Qatar Airways Group's flexibility and resilience in successfully navigating a constantly evolving global travel industry, and indicates a strong and sustained rebound from the challenges faced by the sector in recent years."

### 1.9mn now displaced in Gaza: UN

The UN humanitarian coordinator for Gaza said yesterday that 1.9mn people were now displaced in the territory, adding she was "deeply concerned" by reports of new evacuation orders for Khan Yunis.

The United Nations has estimated that up to 250,000 people are impacted by the Israe order for civilians to leave Al-

Qarara, Bani Suhaila and other localities near the territory's second city of Khan Yunis. "Over 1 million people have been displaced once again, desperately seeking shelter and safety (and) 1.9 million people are now displaced across Gaza... I'm deeply concerned about issued in the area of Khan Yunis,' Sigrid Kaag told the UN Security Council. "Palestinian civilians in Gaza

have been plunged into an abyss of suffering. Their homes life shattered, their lives upended. The war has not merely created the most profound of humanitarian crises. It has unleashed a maelstrom of hur misery," Kaag added. Page 6

#### Labour minister chairs Workforce Planning Committee's first meeting



E the Minister of Labour Dr Ali bin Smaikh al-Marri chaired yesterday the first meeting of the Workforce Planning Committee, with HE Abdulaziz bin Nasser al-Khalifa, President of the Civil Service and Government Development Bureau and Secretary-General of the National Planning Council, as vice-chairman, along with other committee members.

The committee includes representatives from various government ministries and agencies, such as Defence, Interior, Finance, Commerce, Education and Higher Education, Labour, Qatar Central Bank, QatarEnergy, the National Planning Council, and Civil Service and Government Development Burgan

During the meeting, the Work-

force Planning Committee reviewed its principles and developed a work plan to ensure alignment with the Third National Development Strategy 2024-2030. This strategy focuses on enhancing labour market productivity by leveraging national talent with advanced skills, skilled expatriate workers and increasing the national workforce in the private sector.

The Workforce Planning Committee was established by Cabinet Decision No 4 on March 3, 2024. According to this decision, the committee is responsible for coordinating between government entities and the private sector for effective workforce planning. Its duties include addressing challenges, setting guidelines and future goals for employment in

both sectors, evaluating educational achievements in the country, aligning them with current and future labour market needs, and examining and recommending factors that influence employment rates in government and key private sector economic fields.

Qatar aims to enhance its workforce skills through recruitment policy reforms, new visas for entrepreneurs, students and elite talent, as well as encouraging the private sector to hire more Qataris in medium to high-skilled positions, launching national workforce development initiatives in partnership with private companies, and improving higher education to meet labour market demands, with the goal of achieving a 46% highly skilled workforce. (QNA)

## Doha hosts UN, Special Envoys' meetings with Afghan civil society

oha hosted yesterday the meeting of UN Under-Secretary-General for Political and Peacebuilding Affairs Rosemary DiCarlo and the Special Envoys' convening with representatives of the Afghan civil society as part of the 3rd meeting of Special Envoys on Afghanistan.

DiCarlo said that she listened to valuable insights and perspectives from members of the Afghan civil society, and presented to special envoys and the United Nations, regarding the rights of women and minorities in the country, as well as girls' education, media, business and other wide-ranging issues.

She added that the participants shared viewpoints on the Doha process, along with the engagement between Afghanistan and

international community in general, highlighting that the meeting was extremely critical and useful and was based on the outcomes of the previous meeting held in Doha last February.

DiCarlo affirmed that the diversity of opinions heard from the participants and the talks held with the authorities underlined that Afghan civil society is not homogeneous, and there is a need to build trust and to engage in honest dialogue, based on the precepts of the United Nations Charter and various human rights treaties to which Afghanistan is a party.

This process is based on the independent evaluation recognised by the United Nations' Security Council last November, which calls for more co-ordina-

tive process with unequivocal conditions and expectations of all parties, DiCarlo noted, and called for pursuing a principled step-by-step approach with a clear understanding of outcomes and commitments from all parties, where human rights, particularly the rights of women and girls, and inclusion remain integral parts of all discussions.

Regarding the next phase of discussions, DiCarlo said there have been discussions on establishing smaller groups around key issues in the independent assessment.

She assured that the discussions will proceed, as they are still at the beginning of the process, but said it will take time and patience, since UN's approach has one goal which is to assist all people of Afghanistan. (QNA)

Your Startup: There are a lot more options than you think! show-cased the types of startups and startup stages in addition to sharing the various sources of financing available to entrepreneurs globally and in Qatar.

Milaha's vice-president for container shipping, Peter Verheijen, spoke in the panel discussion on *Green Supply Chains – Driving Decarbonisation at Scale*, discussing key points including transport decarbonisation, lower carbon supply chains, accelerating zero-emissions transitions, and circular supply chains.

QDB senior manager of investment Mohamed al-Emadi contributed to the session on Does Place Matter? Where To Found a Startup and How To Go Global, discussing the various options startups should consider as they think of going global, particularly what is available in Oatar.

#### **GU-Q students learn to tackle climate change on trip to Greece**

Students from Georgetown University in Qatar (GU-Q) have reflected on a journey that had transformed their understanding of climate change.

They had spent two weeks in Greece as part of the "Greece Summer Symposium: Adaptation in a Climate Change Hotspot", a programme jointly organised by the GU-Q and Georgetown University's Earth Commons Institute hub in Greece to study and find solutions to environmental challenges in Greece.

The immersive trip is part of a new GU-Q environmental science course offered in the fall.

With recent wildfires and rising temperatures outpacing the global average, Greece provided a vivid context for their studies.

Fourteen GU-Q students from 12 countries crisscrossed the nation, from Athens' historical sites and forests that faced recent catastrophic wildfires to organic farms on the islands of Andros and Paros and cutting-edge desalination plants on Syros Island.

They explored ways to save water, such as collecting rain and reusing greywater, and spoke with locals about reducing waste

and protecting marine life.

"We wanted students to grasp the bigger picture – how climate change affects water resources, food security, ecosystems, and entire communities," said Prof Raha Hakimdavar, who designed and is teaching the course.

Throughout the symposium, students participated in workshops, field visits, and discussions led by local and regional experts, gaining insight into Greece's unique challenges and innovative approaches to environmental management and sustainability.

This hands-on learning enhanced the students' ability to "fully understand and explain complex environmental issues to anyone", according to Prof Hakimdayar.

The students' diverse experiences, like learning about farming methods that protect the environment on Andros Island and Paros, will inform future policy recommendations focused on eco-friendly tourism, water conservation, and community engagement

gagement.

By the end of the symposium, students left Greece with a

stronger sense of environmental stewardship.

Reflecting on the journey, Prof Hakimdavar said: "There is no better way to learn about environmental issues than in the field with experts. Through the unique immersive component of this course, we hope to inspire our students to lead the fight against global challenges."

Over the next few months, students will work in groups to develop targeted solutions to the environmental challenges observed during their trip.

The novel approaches developed through these final course projects will then be shared with the programme partners in


#### AJCS releases book on Palestinian national security

The book investigates various aspects pertaining to the concept of national security, with a focus on the approaches of small states towards their national securities, and then moves on and addresses Palestinian national security in depth, considering the Palestinian geopolitical reality, the unfolding of Palestinian security work, and the applicabil ity of the concept of national security to the Palestinian reality, in light of its own particularity. It also discusses challenges relating to Israel, notably the ongoing Israeli expansion in service of security interests, resulting in control over Palestinian land as well as the tightening blockade of the Gaza Strip and Palestinian communities in the West Bank. in addition to Israeli dominance over the Palestinian economy and its dependency on Israel. Al-Najjar then goes on to discuss the impact of regional and international factors and players linked to Palestinian national security, pointing to the Palestinian people's lack of a strategic international ally against the backdrop of Israel's strategic alliance with the US. He also touches on the nature of the international world order and the composition of the UN Security Council. (QNA)

#### **Amir's participation in SCO summit 'increases** significance of event'

azakhstan's ambassador to Qatar Arman Issagaliyev has stated that that the working visit of His Highness the Amir Sheikh Tamim bin Hamad al-Thani today to Kazakhstan comes in the context of the distinguished bilateral relations built on support and mutual respect between the two friendly countries.



In remarks to the Qatar News

Agency (QNA), he said that His Highness the Amir's participation in the Shanghai Co-operation Organisation (SCO) Summit will remarkably increase the significance of this event, given Qatar's active role in mediation to resolve international conflicts and disputes, and its constructive position on a number of pressing issues of sustainable development.

Issagaliyev noted that Qatar possesses tremendous advantages and experience in various fields, including economy, politics, and energy, and expressed confidence that Qatar, as a dialogue partner state in the SCO, will make a significant contribution to finding the most acceptable solutions according to the organisation's agenda.

He said that Qatar and Kazakhstan work together in many areas, citing the two historic state visits of His Highness the Amir to Kazakhstan in 2022, and the visit of President of Kazakhstan Kassym-Jomart Tokayev to Qatar in February this year, and the number of agreements and memorandums of understanding that have been signed between the two countries in various fields.

In March this year both countries signed an agreement to establish a long-term strategic partnership for developing projects in priority

The governments of both countries are now actively working on implementing the agreements reached, including joint projects in the fields of energy, agriculture, and healthcare.

To date, companies based in Qatar have already entered the telecommunications and banking sectors in Kazakhstan, which will contribute to increasing competition and improving service quality.

As a next phase of co-operation, information technology and infrastructure projects could be among the promising areas, given Qatar's extensive positive experience in these fields.

Issagaliyev believed that the results of the upcoming meeting would provide additional momentum to the entire scope of bilateral relations as part of enhancing the strategic partnership between Kazakhstan and Oatar.

Regarding the SCO, the envoy said that the organisation is today one of the most influential in mainland Asia.

The organisation's nine member states, home to more than 3.5bn  $\,$ people, account for a quarter of global GDP and more than 15% of

Possessing significant political influence, significant economic opportunities and colossal human resources, the SCO is able to make a significant contribution to achieving sustainable development goals and overcoming modern challenges of humanity.

"Kazakhstan, as the presiding country in the SCO, will continue to enhance the organisation's global role, helping to strengthen friendship and good neighbourliness," Issagaliyev said. "To this end, we have identified six main priorities for our chairmanship in the organisation: ensuring security and stability in the SCO space, expanding trade and economic ties, strengthening energy co-operation, expanding co-operation in the digital sphere, strengthening interaction in the field of ecology, and developing cultural and humanitarian ties."

The envoy added that Kazakhstan intends to continue consolidating international efforts aimed at providing assistance to the Afghan people under the auspices and with the co-ordinating role of the UN.

Astana counts on the support of the SCO in the implementation of the Kazakh initiative to create a UN Regional Centre for Sustainable Development Goals for Central Asia and Afghanistan in Almaty.

To expand trade and economic relations in the SCO region, Issagaliyev said that Kazakhstan proposed to focus on creating favourable conditions for increasing mutual trade turnover, removing existing

trade barriers, and launching joint ventures. To increase the investment attractiveness of the organisation, Kazakhstan is calling for the use of the Astana International Financial Centre to stimulate direct and portfolio investments in SCO regional projects

Issagaliyev highlighted that Kazakhstan places great importance on developing transportation and implementing regional infrastructure projects within the SCO region and has proposed creating a part-

nership network of major strategic ports and logistics centres. The envoy said that at the upcoming SCO Astana Summit, the member states will agree on and adopt the SCO Energy Strategy, pointing out that an important feature of modern world development is the rapid introduction of digital technologies into all spheres of life,

which form the basis of the economy of the future. Therefore, he added, Kazakhstan aims to expand co-operation between the SCO countries in the digital sphere, both to systematically reduce the digital divide between different countries and social groups, and to provide favourable conditions for their sustainable economic development.

## **Qatar working on enhancing ties** with Asian countries, says envoy

atar's ambassador to Kazakhstan Abdullah bin Hussein al-Jaber has emphasised Qatar's commitment to strengthening its relations with Asia, particularly through successful cooperation with influential organisations.

He noted that Qatar was among the first Arab countries to obtain the status of "Dialogue Partner" in the Shanghai Co-operation Organisation (SCO).

In a statement to the Qatar News Agency (QNA), the envoy said that Qatar also enhanced its position in the region through successful co-operation with the Conference on Interaction and Confidence-Building Measures in Asia (CICA), the Asian Parliamentary Assembly, and the Asia Co-operation Dialogue.

He said that in September 2022, Qatar signed a memorandum of understanding (MoU) to join the SCO as a Dialogue Partner during the organisation's summit in Uzbekistan.

Al-Jaber noted that this status is a preliminary step before granting full membership.

He said that, as a Dialogue Partner, Qatar can attend open meetings of the Council of Foreign Ministers of the SCO member states and meetings of the heads of government of the member states.

However, a Dialogue Partner does not have the right to participate in preparing and signing the organisation's approved documents.

Al-Jaber said that Qatar is just getting started with the process of gaining full membership in the organisation.

The SCO's main aims, the envoy said,



are to build mutual trust, friendship, good neighbourliness, and multifaceted co-operation to maintain and strengthen regional peace, security, and stability, address emerging challenges and threats collectively, and promote effective cooperation in various fields, in addition to enhancing economic growth as well as social and cultural development.

Al-Jaber highlighted Qatar's regional and international role, saying that Qatar is a key player both regionally and internationally in mediation and goodwill ef-

The envoy explained that Qatar's location in the Middle East, a region marked by tensions and conflicts among influential regional powers, has driven it to adopt dialogue, mediation, and preventive diplomacy as part of its foreign policy.

He added that the country has achieved significant success in finding solutions to ongoing conflicts, extending beyond the Arab region to Africa, Asia, and even Latin America, including mediating a prisoner exchange agreement between the US and Venezuela.

Al-Jaber emphasised that Qatar's belief in soft power, international law, and neutral policy, without personal interests, has earned it a reputable international standing and credibility.

On Qatar-Kazakhstan relations, the envoy said that official relations began in 1993 with the signing of the diplomatic

relations agreement. Since then, he said, this relationship has become a strategic partnership, reflecting the strong desire of both countries' leaderships to enhance their friendly relations, as demonstrated by numerous agreements between Doha and Astana covering politics, trade, investments, security, healthcare, energy, and food.

Al-Jaber added that there are promising prospects for joint investment projects, particularly in the gas sector, with Qatar expected to invest in building a gas processing plant and constructing a gas pipeline in Kazakhstan. - QNA

## Desperate Gazans sleep outside after new evacuation order

ens of thousands of Palestinians fled a southern Gaza district yesterday, forced to

forage for food and water in blistering heat after an Israeli evacuation order set off fears of a major new battle in its war on Hamas. The UN estimated that up to

250,000 people are impacted by the Israeli military order for civilians to leave Al-Qarara, Bani Suhaila and other localities near the territory's second city of Khan Yunis.

Thousands spent the night on the streets as many families have moved so many times since the start of the war in October first week, that they have run out of places of refuge.

Midday temperatures rose above 30 degrees Celsius and there was no shelter, said Ahmed al-Najjar, a 26-year-old resident of Bani Suhaila, whose family fled on Monday but then decided to return home to brave any new fighting there.

Anxiety skyrocketed after the evacuation order was issued late Monday, he told AFP.

"We did not know where we would go and we do not have enough money to buy a new tent,"

"We had to spend the night on the street and that has increased our stress. This morning we decided to go home again. There is nowhere else.

"Whatever happens, happens," he said. "We have nothing to lose

The war started after Hamas' October first week storming of southern Israel.

Israel's retaliatory offensive has killed at least 37,925 people, also mostly civilians, according to data from the health ministry in the Hamas-run territory.

Israel has not specifically said there will be a military operation in southern Gaza, but so far nearly every evacuation order has heralded major battles.

Despite new casualties arriving from air strikes and fighting, the European Gaza hospital started evacuating patients because it is located inside the evacuation

zone, a medical source said.

The UN agency for Palestinian refugees, UNRWA, estimates there are 1.7mn displaced across the besieged territory, out of a population of more than 2mn.

UNRWA estimates there are 250,000 people in the latest zones ordered emptied.

It previously said about 1mn people had fled the southern city of Rafah ahead of an Israeli operation that began on May 7.

"The vast majority of them were already displaced, some multiple times," said UNRWA spokesperson Juliette Touma.

Amid the latest Gaza mass displacement, Bakri Bakri, 39, lay on the ground among hundreds of people on a scrap of land in Khan Yunis

"There is no room for us or any of the displaced," he said. "We just hope a solution can be found." Another Gazan man, Abdullah Muhareb, said his family had already fled their home in the Al-Fokhari district once because of a previous Israeli warning of an impending assault.

"We suffered a lot and lived for a long time in the tent city in Mawasi" on the coast, until the army withdrew from Khan Yunis, said the 25-year-old. "Then we went home again," he said. "There was a lot of damage because of the bombing, but we arranged it like a home and we could rest.

"But there is no rest in this barbaric war." He added that "we have left again and we do not know where to go. We went back to our place in Mawasi, but we could not find it as there are so many displaced. "We slept in the street without shelter, without food, without water. There was bombing around us. We just want this devastation to end, we do not have the energy to endure it anymore."

# Lebanon says Israeli GPS jamming confounding ground and air traffic

ber driver Hussein Khalil was battling traffic in Beirut when he found himself in the Gaza Strip — according to his online map, anyway — as location jamming blamed on Israel disrupts life in Lebanon.

"We've been dealing with this problem a lot for around five months," said Khalil, 36.

"Sometimes we can't work at all," the disgruntled driver told AFP on Beirut's chaotic, carchoked streets.

"Of course, we are losing money." For months, whacky location data on apps have caused confusion in Lebanon, where the Hezbollah group has been engaged in cross-border clashes with Israel.

The near-daily exchanges started after Hamas, Hezbollah's Palestinian ally, launched an unprecedented storming of Israel in the first week of October, triggering the ongoing war in Gaza.

In March, Beirut lodged a complaint with the UN about "attacks by Israel on Lebanese sovereignty in the form of jamming the airspace around" the Beirut airport.

Khalil showed AFP screenshots of apps displaying his locations not only in the Gazan city of Rafah — around 300 kilometres away — but also in east Lebanon near the Syrian border, when he was actually in Beirut.

With online maps loopy, Khalil said "one passenger phoned me and asked, 'Are you in Baalbek?'" referring to a city in east Lebanon.

"I told her: 'No, I'll be at your location (in Beirut) in two minutes?" Numerous residents have reported their online map location as appearing at Beirut airport while they were actually elsewhere in the capital.

But the next day, disturbances increased around the Palestinian territory and also along the border between Israel and Lebanon.

On June 28, the level of interference showing on the site was high above Lebanon and parts of Syria, Jordan and Israel.

An AFP journalist in Jerusalem said her location appeared as if she was in Cairo, Egypt's capital about 400 kilometres away.

The interference has at times extended to European Union member Cyprus, some 200 kilometres from Lebanon, where AFP journalists have reported their GPS location appearing at Beirut airport instead of on the island. "Israel is using GPS jamming to disrupt or interfere with Hezbollah's communications," said Freddy Khoueiry, global security analyst for the Middle East and North Africa at risk intelligence company RANE.

It is "also using GPS spoofing... to send false GPS signals, aimed at disrupting and hindering drones' and precision-guided missiles' abilities to function or hit their targets," he added.

The Hezbollah has "a large arsenal" of such GPS-assisted weapons, he noted.

The cross-border exchanges have killed more than 490 people in Lebanon — mostly fighters

- according to an AFP tally, with 26 people killed in northern Israel, according to authorities there.

Fears have grown of all-out conflict between the foes that last went to war in 2006. Asked about GPS jamming in

Asked about GPS jamming in northern Israel, where Hezbollah has concentrated its attacks, a spokesperson for Israel's defence ministry told AFP's Jerusalem office that "currently, we are unable to discuss operational matters".

Lebanon's civil aviation chief Fadi El-Hassan said that since March, the body has asked pilots flying in or out of Beirut to "rely on ground navigation equipment and not on GPS signals due to the ongoing interference in the region".

Ground navigation equipment

Ground navigation equipment is typically used as a back-up system. Hassan expressed frustration that "in this technological age, a pilot who wants to land at our airport cannot use GPS due to Israeli enemy interference"

Lebanon is ensuring "the maintenance of ground navigation equipment at all times in order to provide the necessary signals for pilots to land safely," he said. Avedis Seropian, a licenced pilot, said he had stopped using GPS in recent months.

#### Kenya police, protesters clash

Crowds in Kenya's capital Nairobi lobbed rocks and looted businesses as police officers fired tear gas in scattered violence during fresh anti-government protests yesterday following last month's deadly demonstrations, AFP reported from Nairobi.

Activists have continued to agitate online against President William Ruto, despite his decision last week to withdraw a controversial bill that triggered what he has branded "treasonous" protests by Gen-Z Kenyans. The Kenya National Commission on Human Rights (KNCHR) on Monday said that 39 people had been killed and 361 injured during two weeks of protests — with the worst violence occurring in Nairobi last Tuesday — and condemned the use of force against demonstrators as "excessive and disproportionate". It is the most serious crisis to confront Ruto since he took office in September 2022 in a nation often considered a

## Slow art: the master illuminator of Tehran

Tranian artist Mohamed Hossein Aghamiri sometimes labours for six months on a single design, very carefully – he knows a single crooked line could ruin his entire artwork.

In the age of AI-assisted graphic design on computer screens, the centuries-old tradition of Persian illumination offers an antidote to rushing the creative process.

Aghamiri's fine brush moves natural pigments onto the paper with deliberate precision as he creates intricate floral patterns, religious motifs and elegantly flowing calligraphy.

The exquisite artwork has for centuries embellished literary manuscripts, religious texts and royal edicts as well as many business contracts and marriage certificates.

Aghamiri, 51, is one of Iran's

dozen or so remaining masters of the ancient illumination art of Tazhib, which was inscribed last year on Unesco's list of intangible heritage. "It is a very unique job that re-

"It is a very unique job that requires a lot of patience and precision," Aghamiri, a veteran of the craft with over 30 years' experience, said in his downtown Tehran studio.

"It's not accessible to every-one."

Tazhib's non-figurative and geometric flourishes have traditionally adorned the margins of holy books and epic poems.

The artform dates back to the

Sassanid era in Iran but flourished after the seventh century advent of Islam, which banned human depictions.

Aghamiri says it often takes him months to finish one design and that a single misplaced stroke that disrupts its symmetrical harmony can force him to start over.

When AFP visited, he was working on a so-called shamsa design, a symbolic representation of the sun, about 50 centimetres across with intertwined abstract, geometric and floral patterns.

He said he started the piece over four months ago and aimed to fin-



#### Man convicted of planning attack on UK military base

### Indonesian police probe arson claims in death of reporter

Indonesian police are investigating an accusation by a journalists' group that arson was behind a fire that killed a reporter and three of his family, an official said yesterday, a rare incident that has prompted concern over media freedom. Indonesia's association of independent journalists (AJI) blamed arson for a June 27 blaze in the North Sumatra home of a reporter, Rico Sempurna Pasaribu, after he reported on illegal gambling involving local officials. The *Kompas* newspaper said the journalist died along with his wife, one of his children and a grandchild, citing his daughter.

# Sri Lanka to save \$5bn from bilateral debt deal

Sri Lanka will save \$5bn following the restructuring of its bilateral debt, much of which is owed to China, through slashed interest rates and longer repayment schedules, the president said yesterday.

The nation defaulted on its foreign borrowings in 2022 during an unprecedented economic crisis that precipitated months of food, fuel and medicine shortages.

President Ranil Wickremesinghe said a deal struck last week had secured a moratorium on debt payments until 2028, extending the tenure of loans by eight years and cutting interest rates to an average of 2.1%.

Wickremesinghe said bilateral lenders led by China, the government's largest single creditor, did not agree to a reduction on their loans but the terms agreed would nonetheless help Sri Lanka.

"With the restructure measures we have agreed, we will make a saving of \$5bn," Wickremesinghe told parliament in his first address to the legislature since the debt deal.

Some of Sri Lanka's loans from

China are at high interest rates, going up to nearly 8% compared to borrowings from Japan, the second largest lender, at less than 1%.

largest lender, at less than 1%.
Sri Lanka struck separate deals
with China and the rest of the bi-

lateral creditors, including Japan, France and India.

Bilateral creditors account for 28.5% of Sri Lanka's outstanding foreign debt of \$37bn, according to treasury data from March. That excludes government-guaranteed external loans.

China accounts for \$4.66bn of the \$10.58bn that Sri Lanka has borrowed from other countries.

Wickremesinghe said he expected to complete shortly the restructure of a further \$14.7bn in external commercial loans, including \$2.18bn from the China Development Bank.

Japanese Foreign Minister Yoko Kamikawa hailed the agreement after a meeting with her visiting Sri Lankan counterpart Ali Sabry in Tokyo, according to a news release from the Japanese foreign ministry.

She said Japan would be prepared to resume lending to existing yenloan projects once Japan confirms the Sri Lankan government's intention to work expeditiously towards the conclusion of a bilateral deal on top of the latest debt agreement.

Sri Lanka's 2022 crisis sparked months of public protests that eventually forced the resignation of then-president Gotabaya Rajapaksa after an angry mob stormed his compound.

Wickremesinghe said the nation was bankrupt when he took over and he hoped the \$2.9bn International Monetary Fund bailout he secured last year would be the island's last.

# Philippines vows to protect interests in South China Sea

The Philippines and China yesterday agreed on the need to "restore trust" and "rebuild confidence" to better manage maritime disputes, even as Manila told its neighbour it will be "relentless" in protecting its interests in the South China Sea.

The Philippine foreign ministry said it had "frank and constructive" discussions with China on the South China Sea during the ninth round of talks under their bilateral consultation mechanism, hosted by Manila.

The high-level meeting between senior foreign ministry officials followed what the Philippine military described as the "most ag-

gressive" actions in recent history by China's Coast Guard against its vessels during last month's routine resupply mission that seriously injured a Filipino sailor.

"There was substantial progress on devel-

oping measures to manage the situation at sea, but significant differences remain," the department of foreign affairs (DFA) said in a statement. Earlier in the day, the Vatican's foreign

Earlier in the day, the Vatican's foreign minister Archbishop Paul Richard Gallagher, called for the peaceful resolution of conflicts, including in the South China Sea, which China mostly claims as its own territory.

"We encourage parties in conflict to abide by international law," Gallagher, who is in Manila for an official visit, said in a joint press briefing with his Philippine counterpart. Manila has sought wider international support on its maritime claims, seeking closer ties with countries to advocate for a rules-based order that recognises international law.

The Permanent Court of Arbitration in 2016 said China's expansive claims had no legal basis.

But China, which maintained that its actions in the South China Sea have been lawful and professional, has said that it does not accept any claim or action based on the ruling.

"The Philippines will be relentless in protecting interests and upholding its sovereignty, sovereign rights and jurisdiction in the West Philippine Sea," the DFA said in the statement using the term Manila uses to refer to waters within its exclusive economic

#### Bird flu hits McDonald's breakfasts in Australia

Good luck getting a late-morning McMuffin in Australia. McDonald's has cut breakfast service timings by one-and-ahours, the company said, after a shortage of eggs caused by bird flu outbreaks that have led to the slaughter of about 1.5mn chickens. "Like many retailers, we are carefully managing supply of eggs due to current industry challenges," McDonald's said on Facebook, adding that from yesterday it had stopped serving breakfast at 10.30am instead of the usual time of midday. "We are working hard with our Aussie farmers and suppliers to return this back to normal as soon as possible," the fast food company said. Australia is battling outbreaks of several strains of highly pathogenic avian influenza that have struck 11 poultry facilities. most of them egg farms, in its southeast since May None of the strains are the H5N1 variant of bird flu that has spread through bird and mammal populations worldwide, infecting billions of animals and a small number of humans.

# Police arrest teenager over Sydney stabbing

A ustralian police said they had arrested a 14-year-old boy after a stabbing at the University of Sydney yesterday morning, which triggered a lockdown of the university buildings.

Emergency crews treated a 22-year-old man, who was taken to a hospital in a serious but stable condition, New South Wales state police said in a statement.

New South Wales police assistant commissioner of counter-terrorism Mark Walton told a news conference the boy's motive or ideology had not yet been determined, but expressed concern at increasing evidence young people were being radicalised online.

"They are embracing violent extremist ideologies and moving towards violence," he said.

The attacker was known to po-

lice and government agencies, he added.

The alleged attacker boarded a bus after the incident and was arrested near a hospital, police said. He has been sent for a mental health assessment, police said, and had previously come into contact with the authorities.

There is no ongoing risk to the community, and the victim and the alleged attacker were not known to each other.

A University of Sydney spokesperson said a police operation was underway at its Camperdown campus and that police would remain on campus while investigations continue. Police have cordoned off the crime scene.

The attack comes about two months after six people were killed and 12 injured in a knife attack at a mall in Sydney's Bondi area, and an Assyrian church bishop was wounded in an unrelated stabbing attack during a service in Sydney's west.

## UK baby killer found guilty of trying to kill another child

Pormer nurse Lucy Letby was yesterday found guilty of trying to murder another newborn baby, adding to convictions last year that made her Britain's most prolific serial child killer of modern times.

Letby, 34, was found guilty last August of murdering seven babies and trying to kill six more between June 2015 and June 2016 while working as a nurse in the neonatal unit of the Countess of Chester Hospital in Chester, northern England.

She was jailed for life and told she would never be released. Letby denied having harmed any baby in her care.

Last month, she went on trial for a second time on one count of attempted murder of a further baby girl, known as Child K, a charge on which the original jury had failed to reach a verdict.

Prosecutor Nick Johnson told Manchester Crown Court that Child K was born prematurely at 25 weeks in February 2016 at the hospital, and had been connected

to a ventilator and other machines monitoring her heart rate and oxygen levels.

Little more than an hour after the birth, while other staff were absent, Johnson said, senior doctor Ravi Jayaram entered the room where she was being looked after to find the baby's breathing tube dislodged, alarms that should have sounded had become disabled, and Letby standing there "doing nothing".

Johnson added that on two further occasions that night, Letby interfered with the breathing tube to give the impression there

was a particular problem with the

"These were the actions of a cold-blooded, calculated killer," senior Crown prosecutor Nicola Wyn Williams said in a statement yesterday following the verdict.

Child K died in a different hospital three days later, although the prosecution said this had nothing to do with the allegation against Letby.

In her evidence, Letby again denied having ever harmed any baby put in her care, and said she had no recollection of the night in question. Her defence lawyer said the evidence was not there to prove her guilt.

Letby was originally found guilty of killing the five baby boys and two baby girls by injecting the infants with insulin or air, or force-feeding them milk.

The case shocked Britain and prompted the government to order an inquiry into why concerns about her behaviour had not been heeded by hospital bosses.

Police also said they were carrying out further investigations into whether there were other

victims at hospitals where Letby had previously worked.

For some on social media, Letby has become a cause celebre who was herself a victim of a terrible miscarriage of justice and, ahead of the latest trial, the New Yorker magazine ran an article questioning the evidence against

In May, however, England's Court of Appeal rejected her attempt to overturn her conviction, which had been mainly based on arguments that evidence from the prosecution's expert witness was flawed.

## Parliament removes parts of Gandhi's speech targeting Modi

ndian opposition leader Ra-hul Gandhi's first speech in the new parliament ran into controversy with parts of it, including accusations against Prime Minister Narendra Modi and his party, redacted yesterday for violating the rules of the legislature.

The decision by the Speaker of the lower house came a day after Gandhi made his maiden speech as the leader of the opposition in the chambers, his first official position after two decades as a lawmaker representing the main opposition

Among the sections removed from the speech, which was telecast live by TV channels, were Gandhi's attacks on Modi and his Hindu nationalist Bharativa Ianata Party and what he said were their links to religious hate and violence.

Gandhi also made multiple references to industrialists Gautam Adani and Mukesh Ambani and linked them to Modi and his government, which were removed by Speaker Om Birla, parliament records showed.

Following the speech, federal ministers Ashwini Vaishnaw and Kiren Rijiju told reporters that they met Birla to point out "inaccuracies" in Gandhi's speech and were assured their complaint would be examined. Under Indian

parliamentary rules, the Speaker can expunge or redact words used by lawmakers in the chambers that are deemed defamatory, indecent, unparliamentary, or undignified, following which they cease to exist in parliament's records and can no longer be reported by the media.

Responding to the Speaker's de-

cision, Gandhi said "truth cannot be expunged". He wrote to Birla requesting the redacted remarks be restored, saying they were not violations and conveved the "ground reality" and "factual position".

"Taking off from records my considered remarks goes against the very tenets of parliamentary democracy," he said.

# Hindenburg denies Sebi allegations on Adani issue

'indenburg Research has denied allegations by India's securities regulator that it colluded with a US asset manager to use non-public information to set up a short bet against Adani Group last year, which if proven would breach the country's rules.

Hindenburg posted a copy of a 46-page "show cause" notice from the Securities and Exchange Board of India (Sebi) outlining the allegations on its website on Monday, in the latest twist to a saga that began last year when the US-based shortseller alleged improper business dealings by Adani.

The notice said that six entities including Hindenburg, Kingdon Capital Management and a Mauritius-based trading fund set up by Kotak Mahindra Bank violated certain rules under the Prevention of Fraud and Unfair Trade Practices regulation. It was dismissed in a statement by Hindenburg as "nonsense". Kingdon did not respond to an e-mailed request for comment yesterday. Hindenburg's statement did not mention its relationship with Kingdon and did not respond to an e-mail requesting comment.

"Sebi has neglected its responsibility, seemingly doing more to protect those perpetrating fraud than to protect the investors being victimised by it," Hindenburg said in its statement on the notice, which two sources at Sebi with direct knowledge of the matter confirmed was authentic.

Sebi said in the notice that it had received information from or through the US Securities and Exchange Commission (SEC) in the course of its investigation.

Adani, which has consistently denied Hindenburg's allegations, suffered a loss of as much as \$150bn in combined market value after the report, but its share price has since recovered to the same levels as before. Sebi did not respond to a request for comment yesterday on Hindenburg's statement or the show cause notice. If proven, the alleged breaches could result in financial penalties and the repayment of any gains deemed to have been illegal. Hindenburg said in its statement that it made \$4.1mn in gross revenue through "gains related to Adani shorts from that investor relationship" and just \$31,000 through its short position of Adani's US bonds. It did not name the investor.

"It was a tiny position," said Hindenburg, whose response sheds some light on its Adani short, which intrigued other investors because Indian securities rules make it hard for foreigners to bet against compa-

# 116 killed in stampede at **Uttar Pradesh gathering**

t least 116 people were crushed to death at an overcrowded religious gathering in northern India yesterday, government officials said, the worst such tragedy in more than a decade.

A large crowd had gathered for a sermon by a preacher near the northern Indian city of Hathras, but as they were leaving, a fierce dust storm sparked panic.

Many were crushed or trampled, falling on top of each other, with some collapsing into a roadside drain in the chaos.

"The attendees were exiting the venue when a dust storm blinded their vision, leading to a melee and the subsequent tragic incident," said Chaitra V, divisional commissioner of Aligarh city in Uttar Pradesh.

"We... are focusing on providing relief and medical aid for the victims," the divisional commissioner added.

Senior police officer Shalabh Mathur said that it appeared "more people had come than permission was asked for". Several hours after the crush. Chaitra said

that "the death toll stands at 116", with at least 18 others injured. Most of the dead were women, according

to state chief medical officer Umesh Kumar Lines of ambulances rushed the injured to

Wailing women and crying men gathered outside one mortuary in the town of Etah, where many of the dead were taken, seeking news of their relatives.

#### Heavy rainfall triggers floods, at least 11 dead

eavy rain continued to trigger flood and landslides in India's north and north-east, killing at least 11 people and affecting hundreds of thousands, officials from two affected states said yesterday.

In India's most populous state of Uttar Pradesh, which has been hit by torrential rain, nine people died in rain-related incidents in the last 24 hours, an official bulletin said.

Two people died on Monday in the north-eastern state of Assam, which has been hit by a second wave of flooding since June 16, affecting more than 600,000 people in 19 districts, and displacing more than 8,000, a state disaster management statement said.

The Kaziranga national park in Assam - home to nearly 2,200

one-horned rhinos, or two-thirds of their world population - is also under water, with more than half of its 233 camps flooded, drowning four hog deer, officials said. "The flood water has now en-

tered my house. The water has

damaged my paddy and crops. I have a family of five and I have to take shelter here. If the situation worsens, I will lose my house," Faizul Islam, a local resident told news agency ANI. Visuals from ANI showed inundated fields and roads across

Assam, as people moved precious belongings and furniture from their water-filled homes.

In the northeastern region of neighbouring Bangladesh, the flood situation was worsening rapidly due to continuous rain and upstream water flow from India, leaving tens of thousands of people marooned, officials said yes-

## A resurgent dollar amid persistent **US** exceptionalism

A resurgent US dollar is exasperating central bankers and governments around the world, forcing them into action to relieve the pressure on their own currencies.

The dollar inched higher in Asian trading last week as markets assessed former president Donald Trump was the victor in the first US presidential debate.

President Joe Biden stumbled through early exchanges in the debate, a performance that may intensify worries about his ability to defeat Trump in the November election.

Trump has reiterated a pledge to impose 10% duties on imports should he win in November, a move that could put upward pressure on inflation, potentially delaying interest-rate cuts that could weigh on the greenback.

"Strength in US activity has been a mainstay of our long-dollar bias, and the persistence of US exceptionalism is a major FX theme. But this has always been in the context of high market conviction that the Fed would invariably begin its easing cycle this year. This is now being challenged, and the corresponding de-pricing of Fed cuts has taken the dollar to new year-to-date highs," says Meera Chandan, Global FX Strategist, JP Morgan.

The resurgent dollar is wrecking havoc in Asia this year, putting pressure on central banks to step up the defence of their currencies. Traders are watching for authorities to intervene in Japan while

policymakers in India, Vietnam and Indonesia have all stepped into

"The high-for-longer US rates environment is undermining recovery hopes for Asia currencies," said Christopher Wong, FX strategist at Oversea-Chinese Banking Corp in Singapore. "And now woes are piling on following the renewed weakness in the vuan and the ven. Centra banks may have to resort to stronger intervention to smooth volatility."

The Bloomberg Dollar Spot Index has climbed

almost 5% since end-December as Federal Reserve officials signal that they may hold off on rate cuts until inflation falls sustainably to their target.

The yuan's weakness has also contributed to the Bloomberg Asia Dollar Index's decline of over 3% this year. The Chinese currency has fallen more than 2% in 2024. The weakness in the yen and the yuan is seen to have spillover

effects on regional currencies, especially the won and the Taiwan Other emerging-market currencies have not been spared either,

with the Turkish lira and Brazilian real sliding more than 10% this The greenback has gained against virtually every major peer

in 2024, defying many on Wall Street who came into the year predicting a dollar selloff. That's prompted escalating warnings from Japan on its readiness to intervene to buoy the yen from near

China and Indonesia have moved to steady their currencies, while Sweden and India are also under pressure.

Those intensifying efforts are reminiscent of 2022 when officials in Switzerland and Canada lamented their weakening exchange rates amid a surge in inflation and the strong dollar ripped through emerging economies, contributing to Sri Lanka's historic default.

"The US dollar keeps turning up the heat on other central banks," said Helen Given, a foreign-exchange trader at Monex. "Given the current global environment where central banks appear to be looking to end their tightening cycles, there doesn't seem to be a safe way out from the dollar's continued dominance."

Exchange rates matter because depreciating currencies increase the cost of imported goods, stoking inflation as those expenses feed through to prices in grocery stores and factories. Meanwhile, there's a higher likelihood that money will pour out of a nation with a weak currency in search of higher yields elsewhere - socalled capital flight — harming domestic investment and growth.

The irony, of course, is that unilaterally intervening in currency markets - where \$7.5tn changes hands every day - can only temporarily alter an exchange rate.



# After Biden debate performance, world should prepare for Trump

■he first – and potentially only - debate between the 45th and 46th presidents of the United States constituted a clear win for Donald Trump, as far more viewers focused on Joe Biden's apparent physical and mental infirmities than Donald Trump's evasions and trafficking in partial or outright lies. The question now, though, is what, if any, difference it will make in the presidential election that is now just four months away.

The debate most likely increases the odds that Trump will occupy the Oval Office come noon on January 20, 2025. Going into Thursday night's debate, Trump was slightly ahead in many of the national polls and, more  $\dot{\text{importantly, in the half-dozen}}$ swing" states that will most likely determine the election's outcome. The debate only added to this advantage.

The context favours Trump. This year has already proven to be a tough one for incumbents seeking re-election, as outcomes in India and France have demonstrated (with Britain up next). Polls also show a low approval rating for the prime ministers of Japan and Canada, which could lead to a change of leadership in those countries. Biden and the US are poised to be consistent with this trend. Like many of his fellow

incumbents, Biden has struggled to manage rising immigration and

economic challenges. His failure to deal effectively with the southern border has allowed some 10mn men, women, and children to enter the US illegally. Then there are the effects of inflation, something voters are reminded of every time they go to the grocery store or fill their car with gasoline. Biden can point to domestic and foreignpolicy accomplishments, but they are less salient to many Americans.

Most critical is the question of his age. Doubts are widely and deeply held that Biden is simply too old for what is arguably the world's most demanding and important job. He is 81, turns 82 in November, and, if re-elected, would turn 86 while still in the White House. And he is an old 81. As the debate demonstrated, he walks stiffly, loses his train of thought, and has a weak and raspy voice. Trump is only three years younger and makes little sense when he speaks, often taking bizarre rhetorical deto but manages to project a more vigorous image

Given Biden's better outing at a campaign stop the day after the debate, some believe he can bounce back. After all, Ronald Reagan and Barack Obama recovered from poor debate performances. But that was because they were seen as great orators who simply had a bad night. Biden's problem is that his poor showing reinforced an alreadyentrenched narrative that will be difficult, if not impossible, to alter. His performance could even threaten to turn him into something of a lame duck, further weakening his influence at home and abroad.

All this said, Biden will be

chosen at the party's convention this August unless he takes himself out of the running and frees his pledged delegates to vote for someone else. Who this "someone" would be - Vice-President Kamala Harris, a sitting governor or senator, a member of his cabinet - is anybody's guess.

It is obvious that Biden and his inner circle are resisting calls (including from sympathetic editors at major news outlets) for him to step aside. Neither he nor his loyal lieutenants, many of whom have been close to him for decades, have given any indication that the president will Biden's declining political

fortunes could well prove to be a drag on other Democratic candidates come autumn. It is possible that a Trump victory could help bring about a Republican takeover of the Senate at the same time Republicans hold the House of Representatives. Together with a Supreme Court that has increasingly demonstrated sympathy for positions supported by Trump and congressional Republicans, this would bring about the American equivalent of a parliamentary system, with power consolidated in the hands of a party that is better understood as radical rather than conservative.


There would be few checks on power strong enough to mitigate this imbalance; on the contrary, Trump's plans to weaken the independence of the civil service, together with his promise to politicise the Justice

Department and regulatory agencies, would concentrate power further. Trump would be free to lower taxes, impose tariffs, ease already loose controls on gun ownership, enforce immigration law as he sees fit, and increase the enormous debt.

Foreign policy would also be vulnerable to significant change, because the US political system gives broad latitude to the executive. It is quite possible that Trump would reduce or even eliminate US support for Ukraine, hollow out US commitments to Nato, give Israel an even freer hand to prosecute war in Gaza and Lebanon and build settlements, refuse to participate in global efforts to combat climate change, and prioritise bilateral trade issues with China over broader concerns with Beijing's behaviour abroad.

Elections have consequences, and this one more than most, given that the differences between he candidates far exceed anv similarities. In the wake of a debate that appears to have tipped the scales against Biden, and with no way of knowing if someone else will be the Democratic candidate and how he or she would fare, US friends and allies should prepare themselves for potentially major changes come January. – Project Syndicate

## Orban urges Ukraine truce to spur talks

ungary's Moscow-friendly prime minister Viktor Orban urged Kyiv to work towards a "quick ceasefire" with Russia, while Ukrainian President Volodymyr Zelensky invited Budapest to back his peace moves

Orban, a vocal critic of Western support for Ukraine, was in Kyiv for the first time since Russia invaded in February 2022.

"I asked the president to consider whether...a quick ceasefire could speed up the peace talks," Orban said, adding that such a ceasefire would be "time-limited".

Ukraine has repeatedly rejected calls for a pause in fighting, which it says would just give Russia time to regroup for a fresh assault.

Zelensky instead called on Orban to back Kyiv's steps to work for peace in conjunction with international partners.

"I invited Hungary and Prime Minister Orban to join the relevant efforts," he said in his evening address.

Zelensky also said there were preparations for a possible second international peace summit, akin to one held in Switzerland last

The US meanwhile announced yesterday a new security aid package for Ukraine worth \$2.3bn.

In his video address, Zelensky said Orban's trip to Kyiv, "many years" since his last visit, was a significant step.

Orban is widely seen as the EU's most pro-Russian leader.

In October 2023 he met Russian President Vladimir Putin at a summit in Beijing, becoming the first EU leader to do so since the start of the war.

The populist leader, in power since 2010, regularly criticises Europe's financial and military support for Kyiv and temporarily blocked a €50bn aid package for

#### ■ 210 centrist, left-wing candidates exit French runoff to block far-right

ore than 200 centrist and left-wing candidates pulled out of France's legislative election runoff by a Tuesday deadline, in a move President Emmanuel Macron hopes will block the far-right from winning power.

France votes on Sunday in the final round of snap legislative polls Macron called seeking a "clarification" in politics after his camp was trounced in European elections last month.

His gamble backfired, with the far-right National Rally (RN) of Marine Le Pen winning the June 30 first round. But the key suspense now is whether the RN can get enough seats to form a govern-

Faced with the prospect of the far-right taking power for the first time since France's occupation by Nazi Germany during World War II, Macron's camp and the left have urged a broad "Republican Front" to stop Le Pen's anti-immigration and eurosceptic party.

By last evening's deadline to register, more than 210 pro-Macron or left-wing candidates had pulled out of contests in an attempt to prevent the RN winning seats, in what appeared a welcome development for the presidential

But Le Pen appeared to row back on previous comments that the RN would only form a government with an absolute majority of 289 of the 577 seats in the National Assembly, saying it would still try if slightly below this figure.

She said her party would seek to form a government and make her 28-year-old protégé Jordan Bardella prime minister even with as little as "for example, 270 deputies", requiring them to find support from another 19 MPs to govern.

"If we then have a majority, then yes, of course, we'll go and do what the voters elected us to do." she told broadcaster France Inter.

If Bardella becomes prime minister, this would create a tense period of "cohabitation" with Macron, who has vowed to serve out his term until 2027.

Prime Minister Gabriel Attal, 35, said late on Monday it "would

be catastrophic for the French" to give the far-right an absolute ma-

Yesterday, Attal came under pressure from a 22-year-old voter during a campaign stop in Paris who accused the centrist camp of not doing enough to prevent the ascent of Le Pen's party.

"You don't have the right to leave the world to the far-right," the man told Attal in a tense exchange, adding that people of his generation "are just starting out

Just 76 lawmakers, almost all from the far-right and left were elected outright in the first round of voting at the weekend.

The fate of the remaining 501 seats will be determined in the second round in run-offs between two, three, or in some rare cases, four remaining candidates.

Of the 214 candidates who have decided to quit the race more than 126 are members of the left-wing New Popular Front (NFP) coalition, which came second in the first round, and 78 represent Macron's camp.

An RN candidate yesterday dropped out of the race over a social media post showing her in a cap from the Luftwaffe air force of Nazi Germany, a party official

Just 109 three-way or four-way contests will take place on Sunday compared with the 311 that had been foreseen after the first

But there has been discord within the presidential camp over backing those NFP candidates who hark from the France Unbowed (LFI) hard-left party.

Several heavyweights in the Macron camp, including Economy Minister Bruno Le Maire and former prime minister Edouard Philippe, have argued they should not help candidates from the LFI, which is accused by its critics of extremism and failing to condemn Hamas after the October 7 attack

As tensions rose five days ahead of the ballot, Le Pen accused Maeron of rushing to appoint officials to key jobs in the police and other institutions before any cohabitation in what she described as "a form of administrative coup d'etat".

Macron's office urged her to show "restraint", saying appointments have been part of an established routine.

Most projections in the immediate aftermath of the first round showed the RN falling short of an absolute majority.

Analysts say the most likely outcome is a hung parliament that could lead to months of political paralysis, at a time when France is hosting the Olympic Games.

The chaos also risks damaging the international credibility of Macron, a champion of Ukraine's fight against the Russian invasion who is set to attend a Nato summit in Washington immediately after the vote.

The president has not spoken in public since an EU summit in Brussels on Thursday.

## Meta wisens up to 'martyrs' after a year-long review

Meta Platforms said yesterday it would lift its blanket ban on the word "shaheed", or "martyr" in English, after a year-long review by its oversight board found the social media giant's approach was "overbroad".

The company has been criticised for years over its handling of content involving the Middle East, including in a 2021 study Meta itself commissioned that found its approach had an "adverse human rights impact" on Palestinians and other Arabic-speaking users of its services. Those criticisms have escalated since the onset of hostilities between Israel and Hamas in October. The oversight board, which is funded by Meta but operates independently, started its review last year because the word accounted for more content removals on the company's platforms

than any other single word or phrase. Meta is the parent company of Facebook and Instagram.

The review found in March that Meta's rules on "shaheed" failed to account for the word's variety of meanings and resulted in the removal of content not aimed at praising violent actions. Meta acknowledged the findings of the review yesterday and said its tests showed that removing content when "shaheed" was "paired with otherwise violating content captures the most potentially harmful content without disproportionally impacting the voice". The oversight board welcomed the change, saying Meta's policy related to the word had led to the censoring of millions of people across its

#### **Athens Acropolis offers private visits for €5,000**

The Acropolis in Athens, one of the world's most visited ancient monuments, has begun offering private visits for €5,000 (\$5,400), setting off protests from the site's guards. According to the official website of the culture ministry unit that manages the hilltop site, these group visits will be held outside of normal opening hours and are limited to a maximum of five people each. Normal visits cost €20 or €30 for a combined ticket with other sites. "The Acropolis Experience now offers visitors the exclusive opportunity to enjoy this perfect architectural expression of the Greek spirit in private," says the Hellenic Heritage website. Up to four group visits can take place at a time, beginning at 7am or 8pm on Tuesdays, Fridays and Saturdays. According to Greek media, the first such private visit took place on Saturday with a Russian couple and their private

guide. Yesterday, the site was offering unguided visits starting July 12 and with guides starting August 2. The site says tours can be conducted in English, French, German, Greek, Portuguese, Russian and Spanish. The programme set off controversy when it was first announced last year, and the union that represents guards at archaeology sites said it opposes these private visits that by-pass the usual official guides. The union had not been "given any information about how these visits are organised", said the union's president Georgia Kondvli. "We can understand that there is a financial need behind this measure, but it could have been organised differently." Kondyli added. Ranked as a Unesco World Heritage Site and built in the fifth century BC, the Acropolis has attracted ever growing number of tourists, driven in part by cruise ship passengers.

A Norwegian man appeared in an Oslo court yesterday to face accusations of espionage on behalf of China and will be detained for an initial four weeks, a police official said, in the latest case involving alleged spying by China in Europe. The man, who was not named, was arrested on Monday by the Norwegian Security Police Service (PST) at Oslo's Gardermoen airport upon his return from a trip to China, PST said. "We arrested a Norwegian citizen yesterday morning for what is called serious intelligence activity, benefiting China," PST lawyer Thomas Blom told reporters after the hearing, which took place behind closed doors.

Blom declined to give details of the case, saying police were in an early phase of their investigation, but said the suspect had "attempted" to spy and that "data-carrying devices" were "particularly relevant" as evidence in the case. The detained man says he is innocent, his lawyer said. "He rejects the allegations that he is a spy for China," Marius Dietrichson told Reuters.

The Chinese embassy in Oslo did not comment on the specific case. but said in an emailed statement to Reuters that "certain European" countries have fabricated and hyped up so-called "Chinese spy cases", deliberately smearing and slandering China".

"Some agencies in Norway have repeatedly made irresponsible accusations without providing concrete facts and propagated the 'China threat', which greatly disturbed the normal cooperative atmosphere between China and Norway," it added. In its latest annual threat assessment, published in February, the PST said China would pose "a significant intelligence threat" to Norway, a Nato member and close US ally, in 2024 and over the next few years. "This is mainly due to the deteriorating relationship between China and the West. China's desire for increased control over supply chains, and positioning in the Arctic," it wrote.

## Biden, aides urged to be open about his health


emocrats shocked by Joe Biden's dismal debate performance urged the US president yesterday to be transparent about his mental fitness as he faced the first call from his own side to drop out of the election.

Some supporters have expressed growing doubts about the 81-year-old following last week's televised showdown with Donald Trump, after Biden stumbled over his words and lost his train of thought exacerbating fears about his age.

Congressman Lloyd Doggett became the first Democratic lawmaker to publicly call on Biden to make way for another candidate.

"Recognising that, unlike Trump, President Biden's first commitment has always been to our country, not himself, I am hopeful that he will make the painful and difficult decision to withdraw. I respectfully call on him to do so," the Texan said in a statement.

Nancy Pelosi, a former House speaker and a grandee of the Democratic Party, said in her own statement it was "legitimate" to ask whether Biden's debate disaster was indicative of a deeper problem rather than a one-off.

She praised Biden's vision and "stratehad a "bad night" and said it was fair to raise the mental acuity of "both candinetwork MSNBC - but admitted he had

Democratic Senator Sheldon Whitehouse also asked for reassurances, saying voters needed to know there would be no repeat of Biden's sub-par showing.

Whitehouse, of Rhode Island, told WPRI-TV he was "pretty horrified" by the president's performance during the 90-minute CNN match-up, watched by more than 50mn Americans.

Biden has not given a live interview or held a press conference since the debacle, meaning he has not had to give unscripted comments under pressure again.

On Monday, at the end of a brief speech about a Supreme Court decision, a journalist asked him if he planned to withdraw from the race for the White House. Biden left the room without answering.

The polling margins between the president and his Republican predecessor have been razor-thin and almost static for months, with Trump showing a slight advantage in the all-important swing

Biden pushed for an unusually early first debate in hopes that he could jolt the race while there was still time to build on any momentum gained - but the plan backfired. The White House has always dismissed

questions about Biden's mental acuity, sometimes with marked irritation.

His campaign – under pressure over

its tactics - hit out at "self-important podcasters" in a memo widely seen as a swipe at a group of former Barack Obama staffers and slammed demands from "the bedwetting brigade" for Biden drop out.

"I really do criticise the campaign for a dismissive attitude towards people who are raising questions for discussion," Vermont Senator Peter Welch, a Democrat, told news website Semafor yester-

Observers say Biden has visibly slowed over the last year.


It has been several months since the president, who has fallen in public on several occasions, stopped using his plane's wide gangway, preferring a shorter, more stable staircase.

He has also surrounded himself with aides for the short walk from the White House to his helicopter on the lawn, preventing cameras from focusing on his slow, deliberate walk. Biden, who has always been gaffe-

prone, has not given a long press conference since January 2022 and spends almost every weekend in one of his Delaware homes, with no official schedule.

When he recently visited France to commemorate the 1944 Allied landings, he went straight from the airport to his hotel, where he remained locked up for an entire day, with no public appearances.
